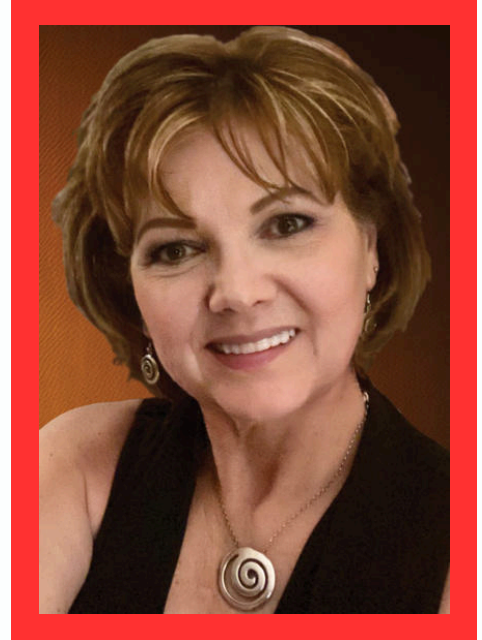
### Kim Caskey.... Quilter, Tour Host, Facilitator

This is a private group journey, based on a minimum of 20 participants to operate. Rates quoted are in CDN dollars, per person. Hotel is subject to change. Due to weather conditions and circumstances beyond our control, the itinerary is subject to change. Should the minimum 20 participants not be met, a full refund will be issued.

### Payment Details:

All payments are made to Kim Caskey Tours in CDN\$ and processed through e-transfer (kim@kimcaskey.ca) or credit card (+3.75%).

- Initial Deposit:
  - \$199 per person non-refundable deposit is required to reserve space
  - Payment options
    - OPTION 1: Payment in full
    - OPTION 2: \$199 deposit + 6 equal monthly instalments November 1, 2026 - April 1 2027)
  - Full and final payment is due by April 1, 2027
- Roommate Cancellation:
  - If you register for a twin room (two travelers per room) and your roommate cancels (before or during the tour), and another roommate cannot be found, you will be responsible for paying the additional "single supplement" charge.
  - If you have purchased Trip Travel Protection insurance, this additional cost may be recoverable through your insurance policy. We strongly encourage you to purchase travel insurance for this and any other emergencies.
- Trip Travel Protection Insurance:
  - Deposits and payments are non-refundable, we strongly recommend purchase of Trip Travel Protection Insurance. Refunds will only be issued should the minimum number of travelers not be reached.

## HEALTH & SAFETY WAIVER – COVID-19

However, there is no way to eliminate all possible risks while traveling and Kim Caskey Tours and Anderson Vacations therefore cannot assume liability in the unlikely event you contract COVID-19. This is the reason for the necessity of the following waiver of liability:

By signing this agreement, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you may be exposed to or infected by COVID-19 while traveling with Kim Caskey Tours and Anderson Vacations and that contact with the virus that causes COVID-19 may result in personal injury, illness, permanent disability, and death. You understand that the risk of becoming infected by COVID-19 on a Kim Caskey Tours/Anderson Vacations trip may result from the actions, omissions, or negligence of yourself and others, including, but not limited to Anderson Vacations employees, suppliers (and their employees) and other passengers.

You understand that you could encounter others, including but not limited to others traveling on this trip, who have COVID-19 or other infectious diseases, or who are infected with the virus that causes COVID-19 or other viruses but who exhibit no symptoms of infection or an infectious disease, which could result in your having serious medical conditions requiring medical treatment in a hospital, quarantine in a government-appointed location, and could possibly lead to death. You agree that having considered these risks, you desire to participate in the Kim Caskey Tours/Anderson Vacations trip and you freely and voluntarily assume complete personal responsibility for the risk of exposure, illness, and death due to COVID-19, even if such injuries or death occur in a manner that is not foreseeable at the time this agreement is signed.

You hereby agree to indemnify and hold harmless Kim Caskey Tours, Anderson Vacations and the Releasees for any claims against Kim Caskey Tours, Anderson Vacations or the Releasees by any member of your family, your heirs or assigns, your estate, your employer, or by any other person for whom or to whom you are or may be responsible, whether at law or otherwise.

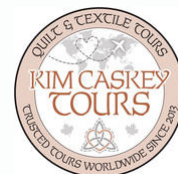
